## New marketing program for City retail businesses

Pleasant Hill retail businesses and restaurants will be able to take advantage of the City's marketing assistance program, which is designed to give businesses a new perspective on marketing and brand new advertising tools.

**The Retail Marketing Incentive Program** will launch effective advertising and marketing campaigns for participating businesses. It begins with a professional evaluation of a participating business's existing marketing tactics, follows with formulation of a new marketing strategy, and finishes with a cost-sharing grant to implement new advertising. Businesses that sign up for the program will receive one-on-one consultation from a marketing consultant and a tailored marketing strategy targeted to the business's customer demographic.

Businesses will be expected to pay a minimum of 20 to 35 percent of the advertising costs, with the City providing the difference at a cap of \$2,500 for individual campaigns and \$5,000 for shopping centers or groups of businesses. Shopping center management companies are strongly encouraged to financially support their retail tenant's efforts.

Funding for the pilot phase of the program should accommodate about one dozen individual sales-tax producing businesses. Participants in the program can rely on having an advertising campaign implemented in 90 days or

less. Those businesses which sign up in mid-March can go from having no marketing whatsoever to having a sophisticated marketing campaign launched by mid-summer.

### More flexibility for businesses to advertise

The City is committed to making it easier for businesses to grow and thrive in Pleasant Hill. With this in mind, and in response to feedback from the business community, the City Council has recently approved changes to the City's zoning ordinance regarding signage that simplify the planning process and offer businesses new options for advertising and improving visibility. The following is a summary of some of the changes that address signage.

#### Signs

##### Zoning Administrator approval.

Certain new signs may be approved by the Zoning Administrator, whereas previously all sign requests (except those under a sites master sign program) were reviewed by the Architectural Review Commission. This results in the streamlining of the review and approval process by approximately three weeks.

##### Adjustments to sign provisions.

This is a new process that will allow both minor and major revisions through a modified process. Previously, any deviations to sign provisions were processed through a variance. The variance included findings that were often difficult to make and added to the time of the review and approval process.

- **Minor adjustments** (up to 20% deviation) are reviewed by the Architectural Review Commission. This removes the additional variance pro-

cess and allows the City greater flexibility when reviewing deviation requests.

- **Major adjustments** (over 20% deviation) are reviewed by the Planning Commission through a conditional use permit and not a variance process. Again, this allows the City to have greater flexibility when reviewing deviation requests.

#### Temporary signs

- **Window signs** with up to 30% coverage (not including glass doors) and not facing or located in a residential zoning district, are now exempt from permit review.
- Two temporary **wall signs** are allowed to be displayed at the same time (provided not facing in the same direction); previously only one temporary sign was allowed at any given time.



- Temporary freestanding **“A” frame** or **“H” frames** signage is now allowed with a permit (up to 20 days, up to six times per year). However, certain design criteria must be met.

Other types of temporary signs that are moving, flashing, animated, searchlight, flag, pennant, streamer, air blown or similar are now allowed with a permit for up to seven days at a time, up to six times a year. Previously, these types of signs were allowed for only five days at a time, for only four times per year.

### Townhall meeting on education with Assemblymember Susan Bonilla

Assemblymember Susan Bonilla will participate in a moderated discussion on education Thursday, March 8 at 7:00pm in the Council Chambers at Pleasant Hill City Hall, 100 Gregory Lane.

Asm. Bonilla will discuss the state of education policy in California, how the Governor's proposed 2012-13 budget will impact local schools, and her vision for education reform. She will also highlight active education-related legislation and offer ideas for how the

Pleasant Hill community can support its schools.

As Chair of the Assembly Budget Subcommittee on Education Finance, Asm. Bonilla will continue to preside over legislative hearings on this topic.

Asm. Susan Bonilla was elected in November 2010 and represents California's 11th Assembly District. However, once the newly-drawn Assembly districts take effect, Ms. Bonilla is expected to represent Assembly District 14, which includes Pleasant Hill.

Asm. Bonilla previously served on the Contra Costa County Board of

Supervisors, representing the County's 4th District of Concord, Clayton, Pleasant Hill and portions of Walnut Creek, and as a Councilmember and Mayor of Concord. Prior to serving as a public official, Asm. Bonilla worked as a high school English teacher in the Mt. Diablo Unified School District.

The March 8 education forum is sponsored by the Pleasant Hill Education/Schools Advisory Commission and is open to the public.

## Register your home or business alarm with the Police Department

Every day the police department responds to alarms at residences and commercial establishments. Last year the police department received over 1,100 alarm calls and only a very small percentage of them (about 3%) were verified crimes in progress.

When alarm calls are received at least one officer is dispatched and, depending on the type of alarm and the time of day or night, additional officers may be sent as well. Often officers are called away from other needed services to respond to these alarms.

In 2007 the City Council enacted changes to municipal code section 9.20 in an effort to control false alarms and promote the health, welfare, and safety of its citizens. The Council found that the installation and use of substandard alarm equipment and the occurrence of false alarms constituted a threat to the safety of officers and the public.

The purpose of the ordinance is to: *“(1) license and regulate alarm systems, alarm users, and the activities of alarm*



*companies in the city; and (2) protect public safety by reducing or eliminating the number of false alarms within the city that prevent, hinder or delay public safety officers from responding to other calls for service.”*

The ordinance is designed to encourage more responsible usage of alarm systems, to facilitate the Police Department’s effective and efficient response to alarms, and to offset costs associated with managing the program.

Residents and business owners who utilize alarm systems are required to complete an alarm registration at the beginning of every year. The registration is valid for one calendar year and must be updated annually. Each registration also contains vital information the police department may need to contact owners in the event of an emergency.

Annual registrations are due every January. The initial permit fee is \$57 but is prorated monthly if not registering for a full year. The renewal fee is currently \$29.

**Alarm registrants are not charged for false alarms on the first occasion, but the City may assess a fee of \$111 for a second false alarm within a calendar year.** Exceptions include multiple false alarms within a 24-hr period, false alarms caused by power failures, alarms cancelled prior to police response, and false alarms occurring during the 30-day period following activation and registration of an alarm system. Of the nearly 1,300 alarm registrants in the city, fewer than 10 false alarm invoices were sent to residents in 2011. ♣

### George “Budd” Primrose

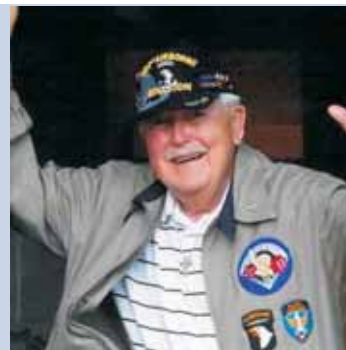

George “Budd” Primrose, who worked for the City of Pleasant Hill from 1970 to 1987, died on July 13, 2011, at age 88.

George was unique in the history of the City in the fact that he held positions in all four City departments. He was hired by the Police Department in 1970 as a Community Service Officer and then served as Interim Superintendent of Maintenance in the Public Works Department in 1974. Following that assignment he worked as Purchasing Agent in the Department of Central Services until 1979, when he became Code Enforcement Officer for the Department of Community Development. He retired from City service in 1987.

Born in Oakland, CA, George joined the Army in 1941 and became a proud member of the 101st Airborne Division and had combat service in Holland at Market Garden and at the Battle of the Bulge in Belgium. He ended his years of service at Hitler’s mountain retreats in Berchtesgaden, Germany. He met his wife Mary in England and they married immediately after the war ended.

In 1947, George became a police officer with Oakland Police Department and remained there until an injury forced his retirement in 1968. In 1963 he and



Mary and their two sons moved to Pleasant Hill where he lived until his death in 2011. In the last decade of his life and after his Mary died, George, with the help of his companion Bea Ball and long-time friend Loydyne Lane, wrote a

fictional novel “LEST WE FORGET” based on his experiences as a Battle of the Bulge survivor and a Band of Brothers veteran.

During the last three years of his life, he was an active member of the Viet Nam Veterans of Diablo Valley, being named Veteran of the Year in December 2010. ♣

By accessing the website, the public can find information on creating a Disaster Plan for their family and putting together Disaster Kits for the home, workplace, and pets. The public can also learn how to prepare for a disaster through a 90-minute class given in their neighborhood or arranging for a 90-minute presentation on Disaster Preparedness to their church, club, or organization. Dates for future CERT classes can also be found on the website.

CERT members will find useful information and maps that show where their assembly areas are located, the FRS Radio channels each area will be using, and reminders on what to do following a

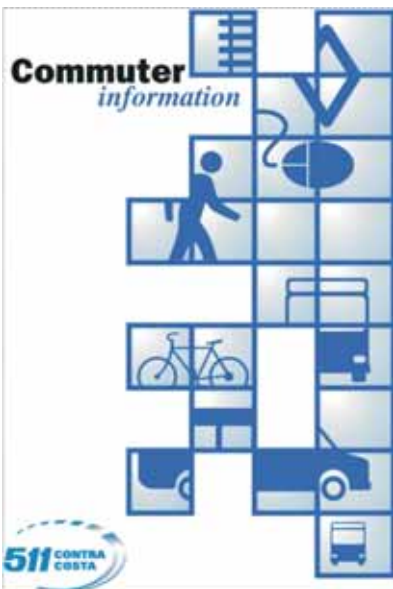
disaster. They will also find the Quarterly Training Dates for 2012 with subjects to be taught and additional training opportunities, as well as training that can be taken online.

## LAFCO seeking applicants for open seats

The Contra Costa Local Agency Formation Commission (LAFCO) is currently accepting applications for the Regular and Alternate Public Member seats.

LAFCO is an independent agency created by the State of California and is charged with encouraging orderly governmental boundaries and efficient services, discouraging urban sprawl, and preserving agricultural and open space resources. The Commission meets these objectives by regulating the boundaries of cities and special districts and conducting municipal service reviews and other special studies.

Contra Costa LAFCO is composed of seven voting members and four alternates. Alternate members participate in meetings, but vote only

when the regular member is absent or has a conflict of interest. The Commissioners will screen applications and make the appointment. The term of office for the open public member seats is four years expiring in May 2016.

Contra Costa LAFCO meetings are typically held on the second Wednesday of each month at 1:30 pm in Martinez. Commissioners receive a \$150 stipend per meeting.

**Requirements:** Applicants must be a resident of Contra Costa County, able to regularly attend LAFCO meetings, have a general understanding of LAFCO functions and authorities, and cannot be officers or employees of a county, a city, or a special district in Contra Costa County. The public members are

considered *public officials* and are required to file a standard annual financial disclosure statement with the California Fair Political Practices Commission.

In order to be considered, a completed application form must be received in the Contra Costa LAFCO office located at 651 Pine Street, Sixth Floor, Martinez, CA 94553 by 5:00 pm, Friday, March 9, 2012. Applications may be submitted by email, fax or U.S. mail; post marks will not be accepted. ### Make a difference—join the CCC Civil Grand Jury

Contra Costa County's watchdog agency, the Civil Grand Jury, is an arm of the Superior Court. Unlike a criminal Grand Jury, this jury does not hear cases, but is an investigative body. It devotes a year of dedicated service to keep careful watch over various aspects of our county government.

A new Grand jury is selected every year. Grand Jurors devote a year of dedicated service to keep careful watch over a myriad of our county's services. They work to ensure that all parts of our county government are acting in the best interest for all citizens of Contra Costa County. They keep their eyes on our education system, health department, law enforcement, and fire fighting agencies and financial offices. When any of these agencies do not perform effectively, Grand Jurors ask the tough questions and make the recommendations that are needed to make changes.

Recent Grand Juries have uncovered questionable practices and issued reports on such things as the county's many pension problems, dwindling resources for elder care, foster children in jeopardy,

truancy, and impropriety in local government. The Grand Jury also shines a light on the good work being done by various entities within the county.

If you've ever suspected irresponsible, unethical, or wasteful practices in county government and wished something could be done about them, you may be interested in serving as a member of the Grand Jury. If you enjoy investigation, critical thinking and fact finding, you just may be the person Contra Costa County needs to help save taxpayer dollars and optimize county services.

#### The qualifications for being a Grand Juror

You must:

- Be a citizen of the United States, age 18 or older and a resident of the county for at least one year.
- Possess ordinary intelligence, sound judgment, and fair character.
- Possess sufficient knowledge of the English language.
- Never have been convicted of a felony, malfeasance, or other high crime.



- Be able to commit to 20 hours a week to this undertaking.

It is beneficial to be able to work collaboratively and to feel a genuine interest and connection to the tasks at hand. Former Grand Jurors would assure you that this commitment is challenging and gratifying.

### Local families needed to host international students

The International Education Center at Diablo Valley College (IEC@DVC) is looking for local families to host international students on a temporary basis while they improve their English skills. Long or short-term placements are available.

Last year, over 400 international students were placed with local host families and there is an immediate need to add additional families to the homestay registry.

Host families that participate in the program are paid a monthly stipend of \$750.00 per student. The requirements for being a host family are simple:

- Provide two meals per day (three meals on weekends) and a private

bedroom for the student—all within a supportive family environment.

- Be involved in the student's life and treat them as a family member.

Host families are not required to consist of the traditional family unit—two parents and children. Rather, all types of families are welcome, including single adults with or without children and couples with or without children. If they wish, families may also host multiple

students, as long as they can provide the appropriate accommodations.

Sharing your home with an international student offers your family a wonderful opportunity to learn about the way of life in a different country, as well as being able to introduce the student to living in America. Learning about the culture, language, and customs of another country can be an exciting adventure, not to mention a rich and rewarding cultural experience that often results in lifelong friendships. ## Bill's Ace Hardware leads the way in 'Going Green'

Celebrating over 60 years of service to the community, the family owned and operated chain of Bill's Ace Hardware stores demonstrates a strong commitment to the community and the environment with several years of certification as a Bay Area Green Business.

The Green Business Program was developed in 1996 by local governments and regional agencies to distinguish small businesses that protect, preserve, and sustain the environment.

The network of stores also includes Bill's Ace Hardware in Martinez, which first opened in 1948 as Vine Hill Hardware on Pacheco Blvd. Bill Wygal and his wife Elva opened the store in response to Bill's need for materials as he built houses. In the late 60s, the store joined the cooperative of Ace Hardware, after which Bill retired and passed the business on to his three sons.

Bill's Ace Hardware stores have been Green Certified for more than ten years. Regarding the decision to go green, third generation owner Bill Wygal said, "Things were going in that direction already. We wanted to represent the community in a responsible way."

He was also aware that businesses were being fined for dumping the wrong things in the trash. "We didn't want that kind of spotlight on us."

The stores shine in their waste reduction and recycling efforts. Paper is

used on both sides, pallets are recycled, broken pallets are available for customer reuse projects, and Styrofoam is sent to a company in Richmond which turns it into glue. Every register and office has a recycle bin which collects receipts, bottles, cans, and more. Batteries and CFL bulbs are sent to the Household Hazardous Waste facility.

As a result, Wygal said his garbage bill has been cut in half. "Every store has once-a-week pickup service. It used to be twice a week."

With an eye toward the future, Wygal said they plan to work with PG&E to install LED lighting in the stores when it becomes cost effective.

Overall, Wygal feels that the Green Business Program helps his company use best practices, keeping them professional and responsible.

"It's simple to just throw things in the trash. But we have to think global and act local," Wygal said. "We're trying to do the right thing. It becomes a way of life. First you start with recycling cans and bottles, then that becomes a habit and it's easy. Then you're ready for the next step."

### March conference focuses on returning military mental health

## Commons Redevelopment Projects

Over the years, the Agency carried out numerous redevelopment projects in the Commons Project Area including:

- ◆ **Pleasant Hill Plaza** shopping center, the Agency's first project in 1978, on the site of the former Pleasant Hill Drive-in movie theater.
- ◆ **Pleasant Hill Village** senior apartment project also developed in 1978, providing 100 units of affordable senior housing.
- ◆ **Somerset** apartment project, built in 1979.
- ◆ **Cleveland Green** townhouse project and **Pleasant Heights** condominiums project, 1980.
- ◆ **Two Worlds** mixed residential/commercial condominium project, developed in 1981.
- ◆ **Woodsworth Park** townhouse project, 1981.
- ◆ The **Terraces** office building, constructed in 1985.
- ◆ **Gregory Centre** office building, also developed in 1985.
- ◆ **Gregory Square** office building and Lyon's Restaurant, now the Original Pancake House, were built in 1989.
- ◆ **Pleasant Hill Square** commercial complex, 1989.
- ◆ The new **City Hall** opened in 1991.

- ◆ **Courtyard Shopping Center** and **Marriott Courtyard Hotel** were built in 1995.
- ◆ **Pleasant Hill Downtown**, including the Century Theater, the Hyatt Summerfield Suites Hotel, and the Crescent Walk Townhomes project, was developed between 1998 and 2002.

## Commons Redevelopment Projects – cont'd

- ◆ The former Contra Costa Shopping Center, anchored by the vacant Montgomery Ward store, was redeveloped in 2005 as the **Crossroads Shopping Center**, with a new Kohl's Department Store and shops.
- ◆ **Marshall's and Friedman's Appliance Store** opened at the Crossroads in 2008.

## Schoolyard Redevelopment Projects

The Agency's redevelopment efforts in the Schoolyard Project Area included:

- ◆ The Chateau III congregate care facility, which includes 26 affordable units, built in 1997.
- ◆ Hookston Senior Homes Project, which entailed the acquisition and renovation of the former Hookston Apartments as 99 affordable senior apartments, completed in 1999.
- ◆ Navlet's Garden Center was built on the site of the old City Hall in 2002.
- ◆ Mark Scott Construction Company offices building, developed in 2003.
- ◆ Gallery Walk Townhomes project, constructed in 2003.
- ◆ The Agency also contributed over \$10,000 to the refurbishment of the Veteran's Monument, located in the Schoolyard Project Area.

## Affordable Housing

The Redevelopment Agency was also responsible for producing and helping maintain affordable housing in our community. The primary focus of these efforts was the Agency's Single-family Residential Rehabilitation Loan Program, which was initiated in 1992. Under the Rehab Loan Program, low-income homeowners received small grants, or loans up to \$60,000, at 3% interest, for such improvements as new roofs and windows, kitchen and bath remodeling, furnaces, water

heaters, energy efficiency, painting and handicap accessibility. More than 120 eligible households received such loans and grants under the program.

The Agency also helped fund the development of over 400 affordable housing units, including Hookston Senior Housing, Grayson Creek Apartments and Pleasant Hill Village, as well as individual units at Gallery Walk Townhomes and Chateau III congregate care facility.

## Increased property values and new jobs

The many accomplishments of the Agency over the years have been both tangible and intangible. The Agency leveraged the expenditure of some \$66 million in local project area property tax revenues over 39

years to help create over \$600 million in private property value. This new development brought over 1,700 net new jobs in the project areas. The development of new commercial, office and residential projects helped strengthen and diversify the City's tax base.



**Perhaps most importantly, the Agency enhanced the image of Pleasant Hill as a stable, attractive community and helped create a “sense of place” for the community by building an award-winning Downtown—all of which has fostered a renewed sense of pride for the people of Pleasant Hill!**

## So what happens now?

Redevelopment agencies financed their operations by capturing the increases in property taxes on the properties in their redevelopment project areas. In Pleasant Hill, property values rose significantly in both redevelopment project areas because of the significant and dramatic improvements made by the Redevelopment Agency particularly in and around the downtown area. This increase in property values, along with the corresponding increases in property tax revenues, funded the redevelopment programs over the 39 year period.

### **Debt obligations and successor agency**

Redevelopment agencies were authorized to incur debt, typically in the form of selling bonds or negotiating an agreement with a developer to financially assist a project, and pledge this anticipated increase in property tax revenues as the source of repayment for such debt. As a result, virtually every redevelopment agency, including the Pleasant Hill

Redevelopment Agency, has some debt that remains to be paid, both to bonds and to development agreements with development companies.

The legislation dissolving redevelopment agencies provides that property tax increment can continue to be collected and used to pay off these debt obligations. This function will be the responsibility of the City of Pleasant Hill, acting under the law as the Successor Agency to the former Redevelopment Agency. The Successor Agency cannot incur any additional debt, and exists only to wind down the affairs of the former redevelopment agency.

The Pleasant Hill Redevelopment Agency was administered over the years very efficiently, prudently and financially conservatively. As a result, its debt obligations are sound, and projections of property tax increment revenues in the former redevelopment project areas are more than sufficient to continue to service these debts until they are paid off.
